



## TENDER FOR THE PROVISION OF MACHINERY FOR PRODUCTION OF WOOD PELLET IN MITROVICA , KOSOVO

FAIR offers financial support to entrepreneurs who are selected through a competitive application process. One of our beneficiaries who have been selected for the support through FAIR is planning to purchase machinery for production of wood pellet in Kosovo. IOM Kosovo invites for offers for the tendering for the listed machinery below.

#### Machine line for production of wood pellet

A completely integrated and industrial turnkey project for wood pellet production plant with the capacity of 1T/h based on raw material like sawdust and wood logs, comprised of:

- a. Feed Conveyor, Drum Chipper, Conveyor, Hopper
- b. Hammer Mill, Subside Roo, Screw Conveyor, Fan, Impulse Dust Collector, Bucket Elevator
- c. Hopper, Screw Feeder, Hot air stove, Rotary Dryer, Fan, Cyclone, Air Lock, Feeding hopper, Screw Feed, Screw Conveyor, Bucket Elevator, Magnet Adapter
- d. Hopper, Pellet mill, Air lock,
- e. Cooler, Fan, Cyclone, Air lock, Bucket elevator, Sieve, Dust collector, Sucking Crusher, Subside Room, Air Lock
- f. Pellet bin, Packing scale, Thermoplastic packing and conveying machine
- g. Main Control Unit
- h. Supporting systems (compressed air, piping and accessories, dust removing, cable / leads / bridge frame system, etc)
- i. At least 12 months of warranty on all equipment parts
- j. Installation on site
- k. Staff training
- l. Transport to Mitrovica, Kosovo
- m. Spare parts and Technical support for at least next 10 years.

Raw material characteristics:

1. sawdust
  - sawdust humidity aprox: 60-50%
  - sawdust made of softwood
2. softwood logs (diameter: 15 cm, length:100 cm).

It is compulsory that the equipment is able to produce wood pellet fulfilling all EU DIN standards' requirements for its final product of wood pellet.

In accordance with the International Organization for Migration IOM Standard Terms and Conditions you are invited to submit a proposal for bidding.

#### Tender Procedure

This will be a two stage tender where the interested competitors are invited to submit all documentation according to the following procedure:

- Phase 1: The submitted documentations will be assessed according to:
- Company profile
  - Bank Reference and Last Financial Statement (Audited)
  - Company Registration
  - Work References

- Phase 2: The pre-qualified companies will be contacted by IOM Kosovo to submit their financial offerings for the above mentioned machinery for final bidding, **BY 5:00 PM ON TUESDAY 10<sup>th</sup> June 2008**
